Dear Parents/Guardians;

Alachua County Public Schools complies with federal and state law concerning the requirements of teacher certification requirements (ESSA sec. 1112(e), Florida Statute 1012.42). This letter is notification that your child has been taught for four or more consecutive weeks by a teacher who has not met applicable state certification or licensure requirements at the grade level and/or subject level area in which they have been assigned to teach.

A State Certified Teacher is one who:

1. Has obtained a Bachelor's degree or higher,
2. Has obtained a Florida Teaching Certificate in the subject areas he/she is assigned to teach.

As of the date of this letter, your child's teacher, Eleanor Forstater has obtained a Bachelor's degree or higher and has obtained a Florida Teaching Certificate for Primary Education and Social Studies but has not yet obtained a certificate for Elementary K-6 Education or the Reading Endorsement.


She is, however, currently working to obtain the required credentials and we have full confidence in her ability to teach effectively in this assignment.





